Many energy-focused states grant upstream and midstream companies multiple breaks on state sales taxes — exemptions that can be worth significant savings. But taking advantage of these tax exemptions requires both time and specialized knowledge. Someone must review invoices, address overpayments and navigate the refund recovery process.

Electricity, chemicals, new construction, downhole well services, manufacturing equipment (e.g., heater treaters, separators, dehydrators, free water knockouts).

► North Dakota

Materials to construct or expand a system used to compress, process, gather or collect natural gas; exemption for generators producing electrical power to run a drilling rig.
