## PLAN FOR SUCCESS

### **ADMINISTRATION**

The key to an effective grant program is setting it up properly from the beginning. With our extensive experience desiging and managing these programs, we know how to help grantors and grant design proper contracts or agreements with grantees, complete internal and external stakeholder analyses and design sessions, define appropriate metrics to track grant progress and success, create dashboards and other visualization tools to communicate progress, and develop open lines of communication to build transparency and accountability. These steps help keep everyone working together toward their common goals.

#### MANAGEMENT

Grant management is the day-to-day execution of those initial plans. It requires collaborative planning among grantor, grantees and subrecipients. It's critical that everyone involved understands the grant objectives and requirements, such as what the grant is intended to achieve, the design principles and governance model, allowable expenditures, HR rules and local and federal reporting. Weaver helps our clients understand these requirements, set up necessary controls, and prevent audit findings or other issues during close-out. We work closely with clients to develop grant management strategies that help maximize grant funding by coordinating benefits from multiple grants and avoiding duplication that can create future de-obligation or claw-backs.

### MONITORING

Grantors, grantees and subrecipients all benefit from grant monitoring. This monitoring begins with careful examination of the grant agreement or contracts, assesses where the biggest risks lie, examines the grantee's or subrecipient's internal processes and capabilities, and then examines transactions to confirm that everything meets the requirements of 2 CFR Part 200, Uniform Guidance.

Weaver's grant monitoring approach is riskbased and preventive, targeting efforts where they are most needed. We assess financial and internal control compliance to ensure grant funds are being spent as intended. We use risk assessments, internal control evaluations and guidance to increase compliance and minimize the risks of clawbacks. Our proactive approach lets us work with clients to find — and fix noncompliance early on.
