TERMS OF ASSIGNMENT Make sure you have clearly and in writing the terms of your assignment, including:
☐ Assignment length ☐ Compensation and employment benefits, including health care coverage, treatment of equity and bonuses, and pension, if applicable
☐ Assurance that your health and life insurance will provide coverage during your assignment ☐ Risk and cost management in the event of unforeseen circumstances ☐ Terms of repatriation
IMMIGRATION
You need to have the appropriate documentation in a timely manner. This may include: Approved work permits
☐ Approved visas for you and your family that cover the entire term of your assignment ☐ Entry filing number
LEGAL
Your new status may raise questions about legal issues, such as:
☐ Will your employment contract change, and, if so, do you have a clear understanding of any legal consequences to these changes?
☐ Will you be subject to different regulations, including those governing employee rights?
☐ Will this assignment affect your will and estate planning?
INCOME AND TAXES
Most international assignments will have some impact on your income and tax payments. Ask these questions:
☐ Will your compensation change? If so, do you understand what to expect?
☐ Do you know how your personal income is going to be taxed while on assignment?
☐ Will you pay taxes in your home country or your host country?
SUPPORT FOR SETTLING IN
Even before your assignment begins, you will need to take steps to get settled.
☐ Have you been able to visit the new location before leaving for your assignment?
☐ Do you have temporary accommodations for you and your family when you arrive?
Mill you and family receive adequate cultural and language training before you leave?
